DEMOLIZIONI INDUSTRIALI S.R.L. considers the continuous improving of its performances, regarding the Environment, as well as Work Health and Safety, as its most important issue for its activity.

Being aware of the fact that the safeguarding of the environment and of the Work Health and Safety represents a competitive advantage in a market, which is getting increasingly wider and demanding quality and responsible behaviour, **Demolizioni Industriali S.r.l.** decided to adopt a Managing System for the Environment, Work Health and Safety in compliance with the international standards, such as: UNI EN ISO 14001: 2004 and OHSAS 18001: 2007.

Demolizioni Industriali S.r.l., after having spotted and assessed all the environmental aspects and the risks due to accidents, possible chance circumstances, emergencies and the specific risks that can occur during the carrying out of its activities, adopted the following policy, aiming at:

- assuring that all the activities would be carried out in compliance with the applicable environmental, health and safety rules and regulations;
- preventing situations that might cause damage to the health of the employees with reference to all working sites of **Demolizioni Industriali S.r.l.**;
- preventing pollution and reducing the consumption of non-renewable resources;
- following up the continuous improving of all its environmental and safety performances;
- defining goals and targets for improving the environmental and safety conditions, to be integrated in the existing and future operational management, in all its operative sites.

As a consequence there in before, the company's Board decided as follows:

- to make the best use of raw materials;
- to plan a systematic maintenance of all company's machines and equipment;
- to have a controlled waste management, promoting reusing or recycling where possible;
- to systematically identify and control all its environmental impacts;
- to reduce possible causes of accidents and illnesses resulting from the company's activity, by means of corrective and preventive actions;
- to promote and implement informative, formation and training programs to all the personnel, in order to spread out the company's Policy and its relative implementation programs, and to provide for giving them the necessary professional competences in order to avoid significant environmental impacts, or accidents and illness risks which may involve them;
- to increase the awareness of all the personnel about the company's targets and the operative systems to be followed, in order to carry out their tasks and reach the prefixed goals in the best security and safety conditions and respect for the environment;
- to select and check its suppliers and contractors also taking into consideration their policy towards the environmental and safety legislation.
- to promote the environmental sensibility as well as the preventive policy of security on the working sites among suppliers and contractors.
